Entrants will be hair tested and final winners will blood and urine tested. All horses entering will be subject to random testing. Horses testing positive for these substances will be declared unplaced and forfeit all winnings. Hair test will be performed at UC Davis. Hair samples will be collected at Grants Pass on June 29, 2024.

For 3 Year old and Up \$500 entry fee to clear the box and draw into the race.

FOR 3 YEAR OLD AND OLDER DULY REGISTERED BY THE AMERICAN QUARTER HORSE ASSOCIATION AND CHALLENGE NOMINATED. THE OWNER AND TRAINER MUST HAVE A CURRENT MEMBERSHIP WITH AQHA.

HORSES RUNNING IN THE BONUS CHALLENGE RACE MUST BE HAIR TESTED PRIOR TO ENTERING THE RACE. HAIR TESTS WILL BE CONDUCTED BY DR. TOM EVERMAN AT GRANTS PASS DOWNS ON JUNE 29, 2024. THE HAIR TEST COST \$300 AND WILL BE PAID BY THE OWNER. THE HAIR TEST PAYMENT MUST BE PAID TO AQHA, NOT TO THE VETERIANRIAN ADMINISTERING THE TEST.

The purse of the race shall consist of the added monies and all fees and shall be distributed as follows: 40% to 1st; 20% to 2nd; 15% to 3rd; 10% to 4th; 6% to 5th; 3% to 6th; 3% to 7th; 3% to 8<sup>th</sup> place.

**Qualifiers for the Bonus Challenge Race will be determined by money earned in 2023 & 2024.**

The racing secretary will determine the top 10 qualifiers and we ask that they be hair tested. If your horse is hair tested and does draw into the race, CRR will credit your horseman's account in PRINEVILLE for the cost of the hair test.

Entries are made with the understanding that the horse or horses so entered will only be allowed to start if in good standing at the time of the actual running of this event.

The rules of the Oregon Racing Commission in effect at the time the race is run govern all races at Prineville,
